Applicant must have possession of a City of Bradford approved application on site while performing the replacement/repair, If applicant has applied as "Self" as being the contractor and a City Official conducts a spot check and a contractor is performing the work other than "self" on site, the applicant will / can be fined for falsifying a City document and they can/will be fined at a minimum of \$250.00.
- Applicant must apply prior to performing the replacement and/or repairs to residential roof. If the residential roof is deemed an emergency situation, please contact the permits department during/after repair is being done and fines will be waived.

The rate of this tax is (6) mills (\$6.00 per \$1,000.00)
