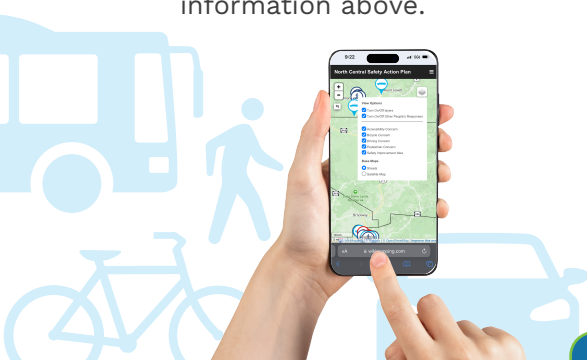
1 ONLINE MAPPING SURVEY
