WHEREAS, the City of Bradford has made emergency home repair grant funds available to City residents through the PHARE Program; and,

WHEREAS the OECD solicits quotations from qualified contractors on behalf of the homeowner and recommends that the work be performed by the contractor providing the lowest acceptable quote for the work; and,

WHEREAS the OECD recommends that PHARE funding in the amount of \$1,450.00 as an emergency repair grant to Virginia Crouse for the removal of a tree that posed a threat of falling on the garage and home located at 166 Constitution Avenue and,

WHEREAS Virginia Crouse will enter into a contract with JIII Specialties, LLC for the emergency removal of the tree at the cost of \$1,450.00.
