- (A) Status conference on public nuisance property at **39-43 Mechanic St.**, which is owned by Wilbur and Donna Wright of York, PA
- * The property was officially declared a public nuisance by the Board of Health during a regular meeting held on Aug. 13, 2024. An appeal hearing was then held on Oct. 1, 2024. At the appeal hearing, the Board of Health voted to allow Mr. Wright to move forward with the renovation of the building, with conditions.
 - (B) Nuisance properties nominated for action in front of the Board of Health
 - (1) **3 Buffalo St**. Rodney A and Chrystal L Griffin. According to city property records, the last known mailing address for the Griffins is 3 Buffalo St. in Bradford, PA. Mr. Griffin possibly currently resides in Westfield, PA. Ms. Griffin possibly currently resides in Oil City, PA. The property is currently in the McKean County Repository in Smethport, PA.
 - (2) **5 Buffalo St**. Samuel A Rotolo Jr., et al. This properly is currently in the McKean County Repository in Smethport, PA. Mr. Rotolo is deceased. City utility files indicate that a sister, Emily J Rainaldi of Ambridge, PA, is the person in care of the property. Ms. Rainaldi is on the vesting deed as a Joint Tenant with the Rights of Survivorship.
 - (3) **19 Buffalo St**. Fred Curtis of Alice, TX.
 - (4) **27 Terrace St.** Curt J Cox of Bradford. According to city property records, the last known mailing address for Mr. Cox is 27 Terrace St. Mr. Cox possibly current resides at a residence on East Main Street in Bradford, PA. This property is currently in the McKean County Repository in Smethport, PA.
 - (5) **11 Tuna Ave.** Joseph F Goodwin. According to city property records, the last known mailing address for Mr. Goodwin is 11 Tuna Ave. Mr. Goodwin possibly currently resides in either Beaver Dams, NY, or Elmira, NY. The property is currently in the McKean County Repository in Smethport, PA.
 - (6) **40 Poplin Ave**. Kathleen Miller (Sherwood). According to city property records, the last known mailing address for Ms. Miller (Sherwood) was at 40 Poplin Ave. Other city records indicate that Ms. Miller (Sherwood) resides in Jamestown, NY.
